SUMMARY AND AUTHORIZATION

Adirondack Park Agency Permit 2021-0122 authorized the construction of a new public/semi-public building (i.e., fire station). This permit amends Permit 2021-0122, as conditioned below, to allow for a change in size and layout of the fire station.

The amendment authorized herein is shown on the following Site Plan: "New Fire Hall Hopkinton Fire District," prepared by Brooks Washburn Architecture DPC, dated May 21, 2021, and last revised October 31, 2023. A reduced-scale copy of the Site Plan is attached as a part of this permit for easy reference. The original, full-scale maps, plans, and reports described in this paragraph and in Permit 2022-0102 are the official plans for the project, with copies available upon request from Adirondack Park Agency headquarters in Ray Brook, New York.

This permit amendment does not convey any right to trespass upon the lands or interfere with the riparian rights of others in order to undertake the authorized project, nor does it authorize the impairment of any easement, right, title or interest in real or personal property.

Nothing contained in this permit amendment shall be construed to satisfy any legal obligations of the permittee to comply with all applicable laws and regulations or to obtain any governmental approval or permit from any entity other than the Agency, whether federal, State, regional or local.

PROJECT SITE

The project site is a 3±-acre parcel of land located on the south side of NYS Route 11B in the Town of Hopkinton, St. Lawrence County, in an area classified Resource Management on the Adirondack Park Land Use and Development Plan Map. The site is identified as Tax Map Section 67.002, Block 2, Parcels 8 and 30 and is described in a deed from Jerome L. Wilber to Hopkinton Fire District, dated July 29, 2021, and recorded September 1, 2021 in the St. Lawrence County Clerk's Office under Instrument Number R-2021-00011670.

CONDITIONS

1. Condition 5 of Permit 2021-0122 is hereby amended to authorize the construction of the public/semi-public building (i.e., fire station) in the location shown and as depicted on the Site Plan last revised October 31, 2023. Any change to the location, dimensions, or other aspect of the fire station shall require a new or amended permit.

All other terms and conditions in Permit 2021-0122 remain in full force and effect.

- 2. This permit amendment shall be recorded in the St. Lawrence County Clerk's Office within 60 days of the date of its issuance.
- 3. All deeds conveying all or a portion of the lands subject to this permit shall contain references to this permit amendment as follows: "The lands conveyed are subject to Adirondack Park Agency Permit 2021-0122, issued May 11, 2022, and Adirondack Park Agency Permit 2021-0122A, issued April 23, 2024, the conditions of which are binding upon the heirs, successors and assigns of the grantors and all subsequent grantees."


