## 1A. Public Meetings & Hearings

This session addresses the goals and requirements associated with holding meetings, in contrast to the purposes and legal requirements surrounding a public hearing. It explores the role of the chairperson in conducting effective meetings and hearings, and includes a discussion of how to manage the public and the media in the context of a hearing or meeting. Also addressed are aspects of the Open Meetings Law, including executive sessions, quorums, minutes, and public notices.

## 1B. Municipal Water Infrastructure - Project Planning, Funding & Implementation

Hotel Saranac Ballroom

Affordable public infrastructure is essential to the sustainability of Adirondack Park communities. Securing funds and implementing complicated public infrastructure projects can be a daunting task for small rural municipalities. This presentation provides Municipal Leaders and Operators with information on grant programs, shares knowledge gained through the successful implementation of public infrastructure projects, and helps set expectations for managing your project. Lauren Townley will provide insight on critical funding opportunities available from the Department of Environmental Conservation through the Water Quality Improvement Project Program and Non-agricultural Nonpoint Source Planning and MS4 Mapping Grant (NPG). The WQIP funds projects that improve water quality or habitat, promote flood risk reduction/restoration, enhance climate resiliency or protect a drinking water source. The NPG grant program aims to prepare nonpoint source projects for construction and application for implementation funding.

Based on her engineering background and project management skills, Carrie Tuttle, will provide insight on the municipal water projects she guided from concept through construction. Mark Hall, as a former elected official and certified water operator, will share his project experience and discuss a recent award-winning drinking water project completed in Star Lake.
