## Projects

P2013-0085, Patelli, Lake Placid, Town of North Elba.
Expansion of a single-family dwelling greater than 40 feet in height with shoreline on Lake Placid. Technical review of stormwater management, erosion and sediment control, shoreline buffer and shoreline structures based upon new submittal and prior site visit. Other involved Agency Staff: Adams (LaLonde)

#### P2010-0193, Reeves, Town of Franklin.

Completed technical and permit review for a greater than 500 square foot hunting and fishing cabin in a Resource Management Land Use Area. Significant issues include potential impacts to wetlands, wastewater management, parking and access. Other involved Agency Staff: Darrah (LaLonde)

P2004-0146A, Nakao, Lake George, Town of Putnam.

Provided analysis of proposed shoreline structures and the need for a variance. The proposal was modified to eliminate need for a variance. Other involved Agency Staff: C. Parker (LaLonde)

P2005-0123A, Peters, Sacandaga River, Town of Wells.
The amendment includes relocating the building envelope, revising the on-site wastewater treatment system design and driveway location for a proposed single family dwelling on Lot 2 authorized in Permit 2005-0123. Mean high water mark and on-site wastewater treatment were evaluated. Other involved Agency Staff: C. Parker (O'Dell and LaLonde)

# P2013-0003, Beaver Brook Outfitters (DBA: Adirondack Fishing Adventures), Town of Johnsburg.

The proposal includes relocation of an existing whitewater/guiding business in a Rural Use Land Use Area. Technical issues remaining include limits of clearing, grading, parking, stormwater management, on-site wastewater treatment and coordination with NYSDOH. Other involved Agency Staff: Darrah (LaLonde)

P1982-0242C, International Paper, Town of Ticonderoga. The proposed amendment includes the construction of a new leachate basin within the International Paper landfill to provide temporary stormwater storage during significant rain events for Area IV Cells 1 and 2. Review was coordinated with NYSDEC and technical comments have been addressed. Other involved Agency Staff: Saehrig (O'Dell and LaLonde)

## P2012-0216, Ariel Ministries, Camp Shoshanah, Town of Chesterfield.

The proposal includes a 25% expansion of the group camp. Technical issues which remain include those associated with a new community wastewater treatment system. Other involved Agency Staff: McSherry (LaLonde)

P2013-0083, Entwistle, White Lake, Town of Forestport.
Conducted a site visit on May 14, 2013 to discuss alternatives associated with a variance application for a shoreline structure within the setback area in a Moderate Intensity Land Use Area.
Other involved Agency Staff: Yamrick (LaLonde)

#### P2011-0195, Burchenal, Town of Keene.

Conducted a site visit with landowner's consultant on May 15, 2013 to evaluate proposed single family dwelling. Significant issues include visibility, stormwater management, on-site wastewater treatment, and access mainly due to steep slopes. Other involved Agency Staff: Saehrig (LaLonde)

P2013-0098, Landvest, Inc., Town of Croghan.

GP for culvert replacement with minor wetland impact. (Rooks)

P2013-0097, NYS DOT, Towns of Indian Lake, Newcomb and Minerva. Route 28N reconstruction. Other involved Agency Staff: Saehrig (Rooks & Bendell)

P2012-0092, Warren County Rail Road vegetation management.
Involves several towns. Herbicide application within 100 feet of wetlands. Other involved Agency Staff: Walrath (Rooks)

<u>P2013-0115</u>, <u>National Grid</u>, <u>Town of Clare</u>. GP for temporary structure (bog mats) in wetland. (Rooks)

<u>P2013-0013</u>, Warren County DPW, Town of Johnsburg.

Replacement of Crane Mountain Road bridge, with wetland impacts.

P2009-280A, Moose Hillock Campground (formerly Chocolate Moose Campground), Town of Fort Ann

Amendment to reduce and revise proposed number of camping lots and amenities. Saehrig (Bendell)

#### P2013-0110, Corasanti, Town of Inlet.

Reviewed applicant submitted soils data for a 2 lot subdivision involving wetlands and the construction of 2 single family dwellings. Other involved Agency Staff: Adams (Ziemann)

P2010-0167, Indian Brook, Lake George Association.
Reviewed wetland mitigation report for constructed sediment basin on Indian Brook. Other involved Agency staff: Walrath (O'Dell and Bendell)

### Pre-Applications

A2013-0068, Mountain View Association, Town of Bellmont.

Meeting with representatives from Lake Association to discuss proposal to manage *Elodea Canadensis*, a native aquatic plant. Staff is concerned about removing a native aquatic plant which potentially could allow the invasive plant, Eurasian watermilfoil, to dominate the area. Staff will be working closely with the lake association to develop a proper monitoring plan and permit application.

#### A2013-0083, Stony Creek Library.

Proposal includes potential relocation and expansion of the existing library into the neighboring church parcel and replacement of the existing on-site wastewater treatment system within 100 feet of wetlands and a waterbody. The water level in the lake was lower than expected following the treatment, but no non-target impacts were identified during the site visit. The Loon Lake Association continues to monitor herbicide concentrations at 8 sample stations and levels appear to be within the norm for this type of treatment.
