One new single-family dwelling and a covered dock is proposed on each of the lots. The project site has 2,530± feet of shoreline on Lake George.

Decription of the Project: The variance request involves the lateral expansion of an existing single family dwelling (2,368 square feet in footprint, including an attached garage and decks) to add a 544-square-foot addition located 109 feet from the mean high water mark of Franklin Falls Pond. The request is, therefore, for a 41-foot variance from the 150-foot shoreline setback from Franklin Falls Pond. Franklin Falls Pond is an impoundment of the Saranac River, which is designated a recreational river in this location by the Wild, Scenic and Recreational River System Act.

Description of the Project: The project as AMENDED on January 25, 2012 is briefly described as follows: A new private airport is proposed on existing agricultural fields. A 1450 foot long, 50-foot wide grass airstrip would be maintained by mowing. The runway is no less than 1400 feet westerly of Route22 and has a north-south orientation. No runway lighting or structures are proposed. A 7-foot tall pole with an orange nylon windsock would be installed adjacent to the runway. Use of the airstrip would be limited to daylight hours during the twelve months of the year. A maximum of 150 take-offs and

landing annually are proposed. No maintenance or re-fueling will occur on-site. The airport will be utilized by single-engine planes only, without horsepower limits.

<u>Recommendation:</u> Direct the project to Public Hearing to obtain information necessary to assess impacts on nearby landowners and/or to deny the project as a prohibited use under Town law.
