"Management of Terrestrial Invasive Plant Species In or Within 100' of Wetlands in the Adirondack Park"

This general permit is proposed to be issued to the New York State Department of Transportation, the New York State Department of Environmental Conservation, the Adirondack Chapter of the Nature Conservancy and the Regional Inlet Invasive Plant Program. The permit is proposed with conditions authorizing the management of terrestrial invasive plant species in or within 100 feet of wetlands in the Adirondack Park.
