Chairwoman Ulrich called the meeting to order at 9:00 a.m. She thanked Mr. Lussi for acting as Presiding Chairman at the February meeting.

#### 1. Public Comment

Bill Farber, on behalf of AATV, thanked all the State agencies involved in the Local Government Day conference. He commented on the large number of attendees and the fact that they stayed until the end of the sessions. He announced that ROOST is participating in Adirondack Days in Albany on April 27. He said Adirondack exhibits will be on display from 11am to 5pm. He thanked Robyn Burgess for her excellent organization of Local Government Days. # 2. Approval of February 12-13 Agency Minutes

On motion of Mr. Craig, seconded by Mr. Lussi, the Agency unanimously adopted the Draft Agency Meeting Minutes of February 12-13, 2015 with edits to clarify and correct comments made by Mr. Booth and Counsel Townsend. ### 5. Executive Director's Report

Executive Director Martino welcomed the students from Clarkson University in the audience. She thanked Robyn Burgess and said this year's Local Government Day was remarkable. She said it was good to hear the keynote address by Basil Seggos expressing his vision of balance for the Adirondacks and announcing Smart Growth funding. She displayed the proclamation by Governor Cuomo announcing April 16 as the official Local Government Day.

Ms. Martino announced Brian Grisi's retirement after being in the Planning Division since 2005 and with the Agency for many more years. She thanked Mr. Grisi for all his contributions to the Agency. She said copies of the Resolution saluting Brian Grisi were distributed. She reported that the Chairwoman presented the Resolution to Mr. Grisi at the Local Government Day reception and that staff honored him with an ice cream social and group activity organized by Robyn Burgess. Chairwoman Ulrich said that Mr. Grisi served as a wonderful ambassador to the 102 towns in the Adirondack Park and was instrumental in the positive changes taking place within the Park.

Ms. Martino thanked Fred Monroe for his leadership in the fight against invasive species. She commented on the ongoing collaboration between the many groups involved with the grant from Governor Cuomo and the identification of locations for temporary boat washing stations in the Park. She said Agency staff determined that no matter the land use classification or area, the location for each wash station will not require an APA permit, order, or variance or require an amendment to an existing UMP. She said staff are available to assist with site visits and to help design any infiltration basin that does not meet guidelines that were established. She also referenced the Memorandum of Understanding Among Public and Private Organizations Regarding Aquatic Invasive Species Prevention in the Adirondack Region and the many diverse organizations that signed it.

Ms. Martino listed some ongoing activities such as the State Land Master Plan amendment review and follow up by Kathy Regan; and the pre-application of the Department of Homeland security Mesonet project in which staff is involved.

Ms. Martino presented an Earth Day Resolution. She said the Agency will also honor Earth Day with a tree planting in May. The Board unanimously approved the Resolution.

Chairwoman Ulrich displayed a picture of a One Square Mile of Hope event held in Inlet in September 2014 which she and members/designees Austin, Wilt, and Scozzafava attended. She invited the attending Clarkson University Adirondack Semester students to present at a future Community Spotlight to share their views. The Chairwoman announced a change to the Agenda that the Local Government Services Committee would present first during committees followed by the Regulatory Programs Committee.

On motion of Mr. Craig, seconded by Mr. Booth, the Agency unanimously approved the Lyme Adirondack Timberlands I, LLC project to timber harvest a 549 acre Colton-Piercefield tract. (P2015-0028)

On motion of Mr. Craig, seconded by Ms. Mahoney, the Agency unanimously approved the second renewal for the David J. Nenni project for the construction of a single family dwelling and associated development on a 4.4 acre parcel of land containing wetlands. (P2007-0011R2)

On motion of Mr. Craig, seconded by Mr. Stegemann, the Agency unanimously approved authorization to receive public comment on the General Permit for Rapid Response Management or Containment of Aquatic Invasive Species Using Benthic Barriers and Hand Harvesting Techniques. (GP 2015-G-1)

Mr. Booth clarified that staff followed the recommendation to include the conditions in both the application and permit.
