DESCRIPTION OF THE PROJECT: The variance request involves the construction of an 8 ft. x 40 ft. elevated one-story covered porch attached to a lawfully pre-existing structure that is located partially within the shoreline setback of Mirror Lake. The porch will extend 8 ft. closer toward Mirror Lake than the existing structure and will be located approximately 22± ft. from the mean high water mark of Mirror Lake at its closest point.
