RESOLUTION #128-2016

Councilperson Hill and Councilperson Olson introduced Res. No. 128 and moved its adoption:

RESOLUTION OF SEQRA NEGATIVE DECLARATION FOR REVISED TOWN ZONING LAW

WHEREAS, the Town Board has created a revised Town of Horicon Zoning Law; and

WHEREAS, Public Hearings were conducted on July 7TH and August 16TH to review the proposed revised Zoning Law including the addition of "group camp" as a Conditional Use in the R-1 Zoning District; and

WHEREAS, the Town Board also decided to further amend the new Zoning Law by revising the proposed commercial boat storage regulations; and

WHEREAS, the Town Board wishes to obtain Adirondack Park Agency approval of the new Zoning Law in order to maintain our APA-approved Local Land Use Plan; and

WHEREAS, the Town Board prepared Part 1 of the State Environmental Quality Review Act ("SEQRA") Full Environmental Assessment Form ("EAF") and was duly designated as Lead Agency for review of the amended Zoning Law under SEQRA; and

WHEREAS, the Town Board has reviewed and fully considered the proposed revised Zoning Law and Part 1 of the EAF and has completed Parts 2 and 3 of the EAF; NOW, THEREFORE, BE IT

RESOLVED, that the Town Board hereby finds that adoption of the revised Zoning Law will not have a significant adverse impact on the environment and authorizes the filing of the completed EAF as the SEQRA Negative Declaration – Notice of Determination of Non-Significance; and be it

FURTHER RESOLVED, that the Town Board hereby reaffirms its acceptance of the amended Zoning Law including the revisions relating to group camps and commercial boat storage and its authorization to refer the amended Zoning Law to the APA for its formal review; and be it

FURTHER RESOLVED, that the Town Supervisor, Town Clerk, Town Zoning Officer and Town Counsel are hereby authorized and directed to take any and all further action as necessary to effectuate the intent of this Resolution.


