DESCRIPTION OF THE PROJECT: The action involves a subdivision into sites by lease and a major public utility use involving authorization for the installation of two 85-foot tall telecommunications towers concealed as simulated pine trees. One tower (South tower - #2) will be installed upon approval, if granted. The total height of each tower will be 90 feet (including crown and concealment branching). A three-sided 12 panel array containing 8 foot panel antennas will be located at 83 foot centerline height above ground level (A.G.L.) with a 4 foot lightning rod. An 11.5± foot by 16± foot equipment platform is also proposed on the 0.23± acre (100 foot by 100 foot) lease area. Access to the facility will originate from Peterson Road and will continue along a new 350± foot long gravel drive to accommodate construction and service vehicles. Utilities will be extended underground along the new access road within the access and utility easement.

<u>ISSUES AND DISCUSSIONS:</u> Horizontal co-location of two new cell towers. One tower is scheduled to be constructed immediately upon approval, the second tower to be installed at a later date.

DESCRIPTION OF THE PROJECT: Construction of a Biomass District Heating System to service the Ray Brook State Office complex, including the office buildings of NYSDEC, NYSP, and the APA. A 660± sq. ft. (16.5± ft. X 40± ft.) building will be constructed to house the biomass operating system components. The building will serve as an education/demonstration center and include a visitor viewing area. The height of the building will measure 16.5± feet from grade to the roof ridgeline. Adjacent to the building, a storage silo is proposed, measuring approximately 12 ft. in diameter and approximately 35 ft. in height with an estimated 50 ton storage capacity. An asphalt driveway around the new building is proposed for access, deliveries, and snow removal. Underground piping will connect the biomass system to each of the three State office buildings. Approximately 7,000 sq. ft. of land disturbance is proposed, including the new driveway and vegetative clearing with an estimated 56 trees being removed from the site.

Verizon Wireless proposes to install a three-sided 12 panel array containing 8 foot panel antennas located at a 76 foot centerline height above ground level (A.G.L.). An 11.6 foot by 16 foot equipment platform is also proposed within a 0.23± acre (100 foot by 100 foot) lease area. Access to the facility will originate from Blue Mt. Road along a new 1427± foot long gravel drive to accommodate construction and service vehicles. Utilities will be extended underground along the new access road within the access and utility easement.
