Adirondack Treetop Adventure - Dane Morton Lake Luzerne: Warren County Low Intensity Use §810 (1)(c)(5)(6) of the Adirondack Park Agency Act

The project is briefly described as follows: A new treetop adventure course tourist attraction consisting of 36 platforms and 44 obstacle features suspended from mature trees within the existing forest. The course includes one platform installed at a height of approximately 63 feet and an approximately 300-foot long zip-line. A new gravel parking lot and restroom building with an attached open-sided picnic pavilion will be constructed on the project site to serve the new tourist attraction and existing commercial use.
