ORDA and Town of Johnsburg Johnsburg: Warren County Hamlet and Low Intensity Use §814 and §809 of the Adirondack Park Agency Act

The project is briefly described as follows: extending and re-aligning Lift 13 (the Village Chair), creating a short new Alpine Trail (12N) to connect the new top of Lift 13 with Moxham ski trail, installing new lighting at the top of Lift 13, Trail 12N and Moxham Trail between Trail 12N and the Village Slopes and converting the current Half and Half glades to an alpine trail. ORDA will also install a high ropes course, a non-linear zip coaster, a miniature golf course and a summer tubing hill having a footprint of approximately 22,500 square feet. Additional lighting will also be installed for parking, safety and security. The village will acquire approximately 3.85 acres from FrontStreet Mountain Development, LLC to undertake the project.
