# 2. Approval of June 13 Agency Minutes

On motion of Mr. Wilt, seconded by Dr. Dawson, the Agency unanimously adopted the Draft Agency Meeting Minutes of June 13, 2019. A copy of the official minutes as adopted by the Agency is on file at the Agency.

Mr. Lussi recused himself from P2019-59, Placid Gold, LLC.

# 4. Motion for Executive Session

On motion of Mr. Lussi, seconded by Mr. Ernst, the Agency unanimously approved the motion for Executive Session. Following the session, Mr. Austin reported the ongoing litigation cases were discussed, and no action was taken.

#### 5. Executive Director's Report

Executive Director Martino thanked Mr. Austin for presiding at this meeting.

Ms. Martino expressed her condolences to the family of Gary Randorf. She paid tribute to him and his environmental conservation work throughout the Park with a slide show of his photography.

She thanked the Governor for the passage of climate change legislation. She said staff would be attending the Interagency Climate Adaptation and Resilience Work Group (ICARWG) workshop on July 16<sup>th</sup> in Delmar.

Ms. Martino applauded the passage of the Health and Safety Land Account which will allow for greater public safety and protection of Forest Preserve lands.

Ms. Martino reported that Adirondack Park Invasive Plant Program (APIPP) received a grant from the Department to continue their work through 2023.

She said it was encouraging news that the Leave No Trace Center would be partnering with ADK and the Department to provide programs for hiker education at high-use trail heads. She said the programs would take place August 7 through August 14.

Ms. Martino announced the promotion of Devan Korn to Environmental Program Specialist 2. She said recruitment continues for an Assistant Engineer position.

She said staff will be attending the 13<sup>th</sup> annual Common Ground Alliance meeting on July 24<sup>th</sup>.

# 6. Motion to Adjourn into Committees

On motion of Mr. Ernst, seconded by Mr. Wilt, the Agency unanimously adjourned into committees at 9:30 a.m.

Mr. Austin reconvened the Full Agency meeting at 3:00 p.m.

## 1) Committee Reports

## a) Regulatory Programs Committee

On motion of Mr. Wilt, seconded by Mr. Ernst, the Board unanimously approved P2019-77, McKavanagh Pond Club Inc., a timber harvest on a 102-acre portion of a 9,808-acre property owned by McKavanagh Pond Club in the Town of Waverly, Franklin County.

On motion of Mr. Wilt, seconded by Ms. Mahoney, the Board unanimously approved P2019-42, Summer Vibes, LLC, variance request to expand a pre-existing single-family dwelling located within the shoreline setback of Upper Saranac Lake with a proposed addition of a 580-square-foot deck in the Town of Santa Clara, Franklin County.

Mr. Lussi recused himself. On motion of Mr. Wilt, seconded by Ms. Mahoney, the Board unanimously approved P2019-59, Placid Gold, LLC, the conversion of an existing 200-seat restaurant into a tourist accommodation containing three living units, and expansion of the structure by 54 square feet to the non-shoreline side.

Mr. Lussi returned to the meeting.

#### b) Park Ecology Committee

Mr. Ernst reported on the Improving Habitat for Forest Birds presentation by Suzanne Treyger, Forest Program Manager, Audubon New York, Cornell Lab of Ornithology.

## c) Park Policy and Planning Committee

On motion of Dr. Dawson, seconded by Mr. Wilt, the Board unanimously accepted the FSEIS for the Town of Westport Map Amendment allowing for ministerial changes as needed.

On motion of Dr. Dawson, seconded by Mr. Stegemann, the Board unanimously approved the staff recommendation to approve the Town of Westport Map Amendment 2018-02 and to approve the Order allowing for ministerial changes as needed upon issuance of the SEQR finding statement. A copy of the FSEIS and Order as accepted by the Agency is on file at the Agency.

## d) State Land Committee

On motion by Mr. Ernst, seconded by Mr. Thomas the committee unanimously adopted the Draft minutes of its June meeting.
