Timber harvest on 643 acres of Lyme's 14,379-acre Perkins Clearing Tract, consisting of two treatments: 509 acres of shelterwood overstory removal, to release a fully regenerated understory, and remove a deteriorating overstory; and 134 acres of free thinning, to harvest mature overstory trees to concentrate sunlight and resources on crop trees. The project site is within a New York State Working Forest Conservation Easement and is certified to both the Forest Stewardship Council and Sustainable Forestry Initiative standards.
