Presiding Member Brad Austin called the meeting to order at 1:30 p.m. Mr. Austin said the Board was meeting remotely due to the COVID-19 virus. He asked members to identify themselves when speaking.

Mr. Austin called for a moment of silence for Tom Saehrig who recently passed away unexpectedly.

1. Approval of March 19, 2020 Agency Minutes

On motion of Mr. Wilt, seconded by Mr. Lussi, the Agency unanimously adopted the Draft Agency Meeting Minutes of March 19, 2020 as amended by Dr. Dawson. Mr. Young abstained as he was not present for the March meeting. A copy of the official minutes as adopted by the Agency is on file at the Agency.

4. Executive Director's Report

Executive Director Martino thanked Mr. Austin for the moment of silence for Mr. Saehrig.

She welcomed Randy Young from Region 6 as the DEC Designee this month.

Ms. Martino commented on NY Pause. She thanked Elizabeth Stankus and Bob Kreider for facilitating staffs' remote work capabilities. She said Governor Cuomo's Executive Order regarding the Agency's timeclocks has been extended until June 7, 2020. She thanked the Governor for his leadership. She said Phase 1 of NY Forward would begin the state's reopening on May 15, 2020.

She announced the retirement of Norma Howard. She said Ms. Howard would be missed and wished her well.

Ms. Martino thanked staff for continuing their work during the pandemic.

5. Motion to Adjourn into Committees

1) Committee Reports

a) Regulatory Programs Committee

On motion of Mr. Wilt, seconded by Mr. Lussi, the Agency approved P2020-44, Town of Minerva, an herbicide treatment of Minerva Lake for the management of Eurasian watermilfoil. No more than 8.7 gallons ProcellCOR EC is proposed to be applied over 41 acres between late May and mid-June 2020 in the Town of Minerva, Essex County.

b) State Land Committee

On motion of Mr. Ernst, seconded by Mr. Lussi, the Board adopted the Remsen-Lake Placid Travel Corridor UMP Amendment Resolution on APSLMP conformance with John Ernst, Arthur Lussi, William Thomas, Dan Wilt, Brad Austin, Lynne Mahoney, and Randy Young voting for, Dr. Chad Dawson voting against. A copy of the Resolution as adopted by the Agency is on file at the Agency.

2) Interim Reports

a) Park Policy and Planning Committee

On motion by Mr. Austin, seconded by Mr. Ernst, the committee adopted the Draft minutes of its March meeting.

The Administration, Economic Affairs, Enforcement, Legal Affairs, Local Government Services, Park Ecology, and Public Awareness did not meet this month. Mr. Lussi said there are still two Enforcement cases pending.

8) Local Government Review Board Comment
