**5. Executed Settlement Agreements:** Two enforcement cases were resolved by settlement agreements executed in July and August:

### E2020-0057, Amy Hill, LLC (Moriah, Essex County)

Resource Management subdivision involving wetlands in 2008. Settlement recognizes the lot as lawful and requires that it be merged with an adjacent lot. Settlement allocates density, requires a permit for any new land use and development and requires filing in the County Clerk's Office.

**E2020-0046**, Luzerne-Hadley Consolidated Fire District (Lake Luzerne, Warren County) Construction of a public/semi-public building in 2018 resulting in a new site less than 0.92 acres in Moderate Intensity Use. Settlement recognizes the public/semi-public building and new site as lawful, authorizes construction of an attached accessory structure, requires silt fence during construction and restricts new lighting and signs. Settlement allocates density, requires prior Agency review prior to any expansion, replacement, or upgrade, or upon failure of the existing on-site wastewater treatment system and must be filed in the County Clerk's Office.
