Dear Adam Zauner:

Thank you for commenting on Adirondack Park Agency project application P2021-0033. Your letter has been included in the project file and will be considered during review of the application.

The construction of the array will require the use of pile drivers for the panel racking, as well as front loaders, backhoes, and bobcats with skid steer forks for the purposes of site alteration. This equipment will only be used during standard construction hours (7 a.m. to 7 p.m., Monday to Friday) and will not exceed decibel levels beyond standard construction levels. Construction will not involve any equipment that creates excessive noise.

After construction, vehicle trips to the site will be minimal – it is anticipated that maintenance will be required on the site approximately 2-3 times per year. These site visits are usually related to site inspection and grass and vegetation maintenance.

My understanding is that there is no noise directly associated with the arrays, but there may be a slight humming typical of electrical distribution lines where the project will connect with existing power grid infrastructure located along Tarbell Hill Road.
