The Regulatory Programs Committee will meet to consider Project 2021-0090, NYS Olympic Regional Development Authority. The project involves the construction of a new office building in Hamlet for Olympic Regional Development Authority (ORDA) employees with 3 floors totaling 29,000 square feet of floor space (approx. 9,620-square-foot footprint). The building will be located on the site of the former Lake Placid Hospital and measure over 40 feet in height.

Also, related site improvements such as parking area construction, utility installation, landscaping, and stormwater management. The building will connect to municipal water and sewer.
