The Adirondack Park Agency has general jurisdiction over the deposit of fill in, excavation of/within and/or draining of a jurisdictional wetland, or any other activity that substantially impairs the functions served by or the benefits derived from a jurisdictional wetland in the Adirondack Park.

The Agency's approval criteria, set forth in § 809(10) of the Adirondack Park Agency Act, mandates that a project can be permitted only when it is consistent with the land use and development plan, compatible with the character description and purposes, policies, and objectives of each land use area; and has no undue adverse impact on Park resources, including the natural, scenic, aesthetic, and open space resources.

The Agency proposes to issue a general permit (GP 2024G-1) and order for certain regulated activities occurring in wetlands subject to Adirondack Park Agency (APA) jurisdiction or in adjacent areas where the activities could substantially impair jurisdictional wetlands. The existing general permit for Minor Regulated Activities in APA Jurisdictional Wetlands (GP 2002G-3AAR) will be revoked and replaced with GP 2024G-1.

The proposed General Permit 2024G-1 titled "Certain Minor Regulated Activities in APA – Jurisdictional Freshwater Wetlands" will provide a streamlined process for certain minor activities involving wetlands that involve no permanent wetland fills or involve minor fills with compensatory wetland mitigation and otherwise have a de minimis impact on existing wetland resources, enabling Agency staff to issue expedited permits for these activities and more time to focus on projects that have greater potential for significant impacts to Park resources.

A certificate issued under GP2024G-1 would include relevant mitigating conditions for meeting the conclusions of law, as specified in the general permit. The certification for the General Permit/Order will include standard conditions related to compliance with the approved project plans, documentation of site restoration, erosion and sediment control, invasive species spread prevention, and vegetative cutting; as well project-specific conditions regarding compensatory wetland mitigation and conditions related to wetland protections for the eligible regulated activities.

Based on the information and requirements set forth above, in Parts 1 and 2 of this Full Environmental Assessment Form, and in the General Permit and Certificate, the Agency finds that there will be no significant adverse environmental impact as the result of the issuance of this General Permit.
