Dear Mr. Ziemann:

I am writing in response to your April 2, 2025 letter to adjoining landowners regarding a permit application to treat milfoil in Eagle Lake with ProcellaCOR EC. I would like to express my **full support** for this application to treat the ongoing infestation of Eurasian Watermilfoil in Eagle Lake.

As I am sure you are aware, Invasive milfoil presents a serious threat to the ecological health, recreational use, and overall enjoyment of Eagle Lake. Its rapid spread chokes out native vegetation and hampers boating, swimming, and other water-based activities. Action is needed, and ProcellaCOR EC offers a scientifically backed, environmentally responsible solution.

ProcellaCOR EC has been rigorously tested and is approved by the U.S. Environmental Protection Agency and New York State Department of Environmental Conservation. It is highly selective in targeting invasive milfoil while leaving native aquatic plants largely unharmed. Its low toxicity and minimal use rate make it one of the safest and most effective herbicides currently available for aquatic plant management.

Nearby Paradox Lake is a compelling example of ProcellaCOR's effectiveness. After treatment, the lake saw a significant reduction of Eurasian Milfoil with no adverse effects reported to native wildlife, recreational activities, or water quality. These outcomes support the safety and effectiveness of the application of ProcellaCOR in Eagle Lake.

Importantly, the Eagle Lake Property Owners, Inc. (ELPOI) has made a clear and sustained effort to keep the community well-informed throughout this process. Three separate public

meetings were held to answer questions and address concerns. Detailed information has been shared on the ELPOI website, in monthly newsletters, and on the Facebook page. These efforts demonstrate a high level of transparency and community engagement.

I commend the thoughtful approach and dedication to protecting the health and enjoyment of Eagle Lake by the association's milfoil committee, spearheaded by Susan Clark. I urge approval of the ProcellaCOR EC application so we can move forward with restoring and then preserving the pristine nature of Eagle Lake.

As a property owner having grown up on Eagle Lake, Ticonderoga, NY, for 68 years, I have watched as Eurasian milfoil has expanded its reach. It has become a significant problem in our bays and in other central areas of the lake. Unsuspecting boaters drive through and chop it into small pieces, allowing it to root and multiply. We have watched homeowners chop it with their motor boats to clear it from their lakefront dock areas, which just makes matters worse.

The lake has used mats and hand harvesting in the past, with little result.

We feel ProcellaCor is the best solution to stop milfoil from further clogging our lake, restoring the lake to its natural state without this invasive, non-native plant.

Good morning Aaron,

I would like to offer my support for Project # 2025-0065. The application of Procella COR EC is much needed in 4 treatment areas of Eagle Lake to begin the control of Eurasian watermilfoil. I continue to hand harvest in the area around my dock but it is not enough to control the spread specifically in the Ti Bay area.

We participated in the milfoil eradication project (divers, harvesting, matting, etc...) led by the ELPOI and Rolf Tiedemann in the 2012-13 era and have continued to collect surface fragments and hand harvest where possible.

We are encouraged by the successful results the ProcellaCOR EC applications have shown in Lake George, Paradox, Glen Lake, Lake Sunnyside and Minerva to name a few.

The low concentration needed for eradication appears successful in doing no harm to other plants, animals and wildlife. It will provide space for the native species to flourish and not impact swimming or drinking water.
